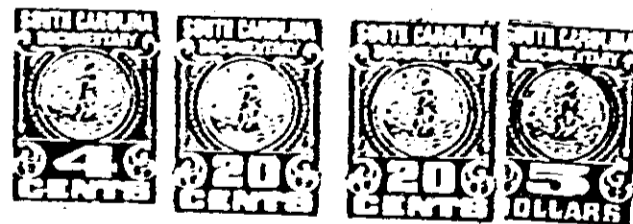

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Bradley Boulevard, being shown as Lot 93 on plat of University Park Subdivision, recorded in Plat Book P at Page 127 in the RMC Office for Greenville County, and having according to said plat, the following metes and bounds:

BEGINNING at an iron pin on the northwestern side of Bradley Boulevard at the joint front corner of Lots 92 and 93 and running thence with line of Lots 92 and 93, N. 37-34 W. 182.5 feet to an iron pin at joint rear corner of Lots 92 and 93; thence with rear line of Lot 121, S. 52-26 W. 75 feet to an iron pin at joint rear corner of Lots 93 and 94; thence with line of Lot 94, S. 37-34 E. 182.5 feet to an iron pin on Bradley Boulevard; thence with said Boulevard N. 52-26 E. 75 feet to the beginning Corner.
