NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of **Greenville**, on the southern side of Greenleaf Lane, being shown and designated as Lot 13, Section II, on a Plat of BELLE TERRE ACRES, dated June 5, 1969, recorded in the R.M.C. Office for Greenville County in Plat Book 4-F, at Pages 8 and 9, containing 2.04 acres, more or less, and having the following courses and distances:

BEGINNING at an iron pin on the southern side of Greenleaf Lane, joint front corner of Lots 13 and 14, and running thence S 35-10 W, 287.1 feet to an iron pin; thence S 48-57 E, 140 feet to an iron pin; thence S 61-31 E, 195 feet to an iron pin at the rear corner of Lot 12; thence N 22-45 E, 295 feet to an iron pin on Greenleaf Lane; thence along said Lane, N 60-13 W, 100 feet to an iron pin; thence N 57-17 W, 100 feet to an iron pin; thence N 51-27 W, 70 feet to the point of beginning.
