NOW THIS INDENTURE WITNESSETH, that the Mortgagor, for the better securing the payment of the said Mortgagee of the said sum of money mentioned in said note or obligation, with interest thereon, and also for and in consideration of the sum of One and No/100 (\$1.00) Dollar to the Mortgagor in hand paid by the Mortgagee, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, sell and convey unto the Mortgagee, its successors and assigns, forever, all that piece or parcel or land situate, lying and being in the County of Greenville, State of South Carolina, described as follows: on the southeastern side of Wade Hampton Boulevard, at its intersection with White Oak Drive, in the City of Greenville, and being known and designated as the northeastern Pt. Panel "A", on a plat entitled Survey for Jack E. Shaw, made by Carolina Surveying Co., 9 Sept. 1975, and having according to said plat the following metes and bounds, to-wit:

Beginning at an iron pin on the southeastern side of Wade Hampton Boulevard (U. S. Highway 29) at the joint front corner of southwestern Pt. Panel "A" and northeastern Pt. Panel "A", and running thence along the said Wade Hampton Boulevard N. 52-26 E. 85 feet to an iron pin; thence following the intersection of Wade Hampton Boulevard and White Oak Drive, the chord of which is S. 82-34 E., 35.36 feet, to an iron pin; thence along the said White Oak Drive S. 37-34 E. 119.2 feet to an iron pin; thence still with White Oak Drive S. 28-33 E. 56.49 feet to an iron pin; thence along the line of Panel "B" S. 52-26 W. 101.15 feet to an iron pin; thence along the southwestern Pt. Panel "A", common line with northeastern Pt. Panel "A", N. 37-34 W. 200 feet to an iron pin, the point of beginning.
