TO ALL WHOM THESE PRESENTS MAY CONCERN:

Jesse L. Hartley and Carolyn P. Hartley (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Five Thousand Two Hundred Fifty and no/100----- DOLLARS

(\$ 5,250.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is five years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that certain piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 35 on plat of Addition to Section 2, Belle Terre Acres, Sheet No. 3, recorded in Plat Book 4X at page 1 and having the following courses and distances:

BEGINNING at an iron pin on Lake El-Je-Ma Drive at the joint front corner of Lots 35 and 36 and running thence along the joint line of said lots, S. 26-36 W. 332.5 feet to an iron pin; thence along the rear line of Lot 35, the following courses and distances: N. 69-22 W. 72.7 feet to an iron pin; N. 63-13 W. 76.3 feet to an iron pin and N. 38-34 W. 313.5 feet to an iron pin in the rear lot lines of Lots 31 and 35; thence along the joint line of said lots, N. 69-16 E. 367.1 feet to an iron pin on Lake El-Je-Ma Drive; thence with said Drive, S. 27-04 E. 56.4 feet and S. 45-47 E. 92.8 feet to the point of beginning.



Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
