Charles Robert Cox and Myrna K. Cox

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Eighty-five Thousand and no/100----- DOLLARS

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All that certain piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 49, Sheet 4, Huntington, recorded in Plat Book WWW at page 26 and having the following courses and distances:

BEGINNING at an iron pin on Raven Road at the joint front corner of Lots 48 and 49 and running thence with the line of said lots, S. 89-14 W. 379.67 feet to an iron pin at the rear of said lots; thence along the rear of Lot 49, S. 07-10 E. 220.45 feet to an iron pin at the joint rear corner of Lots 49 and 50; thence with the line of said lots, N. 89-04 E. 483.75 feet to an iron pin on Raven Road; thence along the said Raven Road, the following courses and distances, N. 33-27 W. 124.8 feet, N. 32-21 W. 107.3 feet and N. 18-29 W. 22.3 feet to an iron pin, the point of beginning.
