BEGINNING at an iron pin on the easterly side of Merrifield Drive, said pin being the joint front corner of Lots 1 and 2 and running thence with the common line of said lots N. 55-42 E. 175 feet to an iron pin, the joint rear corner of Lots 1 and 2; thence N. 34-18 W. 140.1 feet to an iron pin on the southerly side of Hudson Road; thence with the southerly side of Hudson Road S. 52-24 W. 150.3 feet to an iron pin, the intersection of Hudson Road and Merrifield Drive; thence with the intersection of Hudson Road and Merrifield Drive on a curve the chord of which is S. 11-03 W. 36.3 feet to an iron pin on the easterly side of Merrifield Drive; thence with the easterly side of Merrifield Drive S. 34-18 E. 105 feet to an iron pin, the point of beginning.
