MORTGAGE OF REAL ESTATE

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as all

of lots nos. 1, 2, 3, and 4 on a plat of property made for the mortgagee herein by J. Q. Bruce, Reg. Sur., August 21, 1961, said plat being duly recorded in the Office of R.M.C. for Greenville County on September 8, 1961, in plat book WW at page 153.
