(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Four Thousand Two Hundred and no/100----- DOLLARS

(\$ 4,200.00-----), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is five----- years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern side of Rolling Green Road, Greenville County, said State, in Butler Township, being a part of Lot 3 as shown on a plat of Rolling Green Real Estate Co., recorded in Plat Book XX at page 33 in the RMC Office for Greenville County, and being more particularly shown on plat of survey for John W. Brantley, Jr., made January 1971, recorded in Plat Book 4I at page 29, and having according to the latter plat the following metes and bounds:

Beginning at an iron pin on the northeastern side of Rolling Green Road, joint front corner of this lot and Lot 2; thence along said Road, N 10-45 E 436 feet to an iron pin; thence N 54-51 E 358 feet to an iron pin; thence S 20-31 E 150 feet to an iron pin; thence with the common line of property of Joe B. and Toni E. Robertson, S 69-29 W 115.5 feet to point; thence continuing with Robertson line, S 17-05 W 567.8 feet to a point on the northeastern side of Rolling Green Road; thence with said Road, N 59-00 W 175 feet to the point of beginning.

This mortgage is in addition to the mortgage held by Fidelity Federal Savings & Loan Association recorded in Mortgage Book 1253 at page 578.
