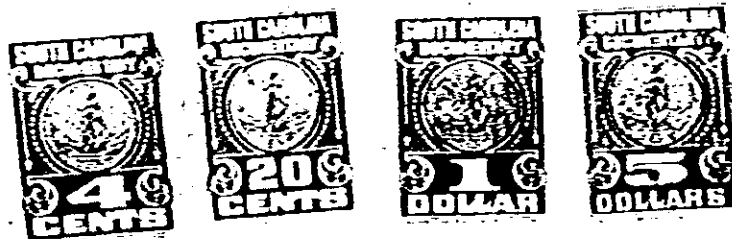

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

ALL that certain piece, parcel or lot of land in Chick Springs Township, near Greer, County of Greenville, South Carolina, at the northeastern intersection of Vaughn Street and Center Street, being shown and designated as Lot No. 20 on a plat of Pleasant View Acres prepared by H. S. Brockman, dated March 22, 1954, revised December 29, 1955, recorded in Plat Book 4T, at Page 90 and having the following metes and bounds, to-wit:
