with interest thereon from date at the rate of 9 per centum per annum, to be paid: monthly

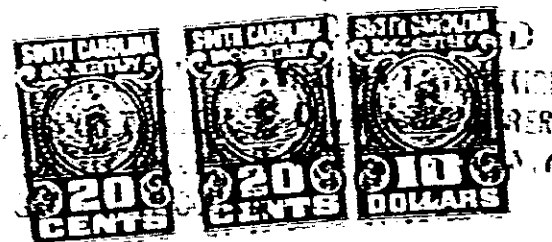

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the City of Greenville, being known and designated as Lot No. 13 as shown on a plat of Oakwood Acres, prepared by J. Mac Richardson, dated September, 1959, recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book "MM", at Page 135, and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of East Lee Road, the joint front corner of Lots Nos. 13 and 12, and running thence along the joint line of said lots, S. 22-55 E. 175-feet to an iron pin; thence N. 67-05 E. 90-feet to an iron pin at a rear corner of Lot No. 14; thence along the line of that lot N. 22-55 W. 175-feet to an iron pin on the southern side of East Lee Road; thence along the southern side of East Lee Road, S. 67-05 W. 90-feet to an iron pin, point of beginning.

The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.
