February 1, 2005, and

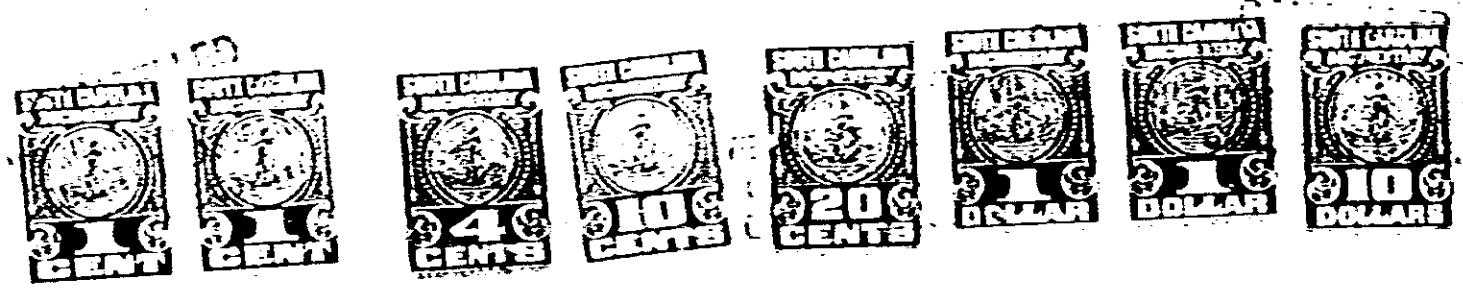

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 58 of Subdivision known as FOREST PARK as shown on plat thereof recorded in Plat Book EE at pages 64 and 65 in the RMC Office for Greenville County and having according to said plat, the following metes and bounds, to wit:

BEGINNING at iron pin on Easterly side of Helen Street at the joint corner of Lots No. 58 and 59 and running thence with the joint line of said lots N. 28-20 E. 140 feet at iron pin; thence N. 61-40 W. 90 feet to iron pin at joint corner of Lots No. 57 and 58; thence with the joint line of said lots S. 28-20 W 140 feet to iron pin on the Easterly side of Helen Street; thence with the Easterly side of Helen Street S. 61-40 E. 90 feet to beginning corner and being the same property conveyed to grantor herein by deed of even date herewith.
