All that certain piece, parcel or lot of land, situate, lying and being on the southeastern side of Mapleton Drive, in the County of Greenville, State of South Carolina, and being shown and designated as Lot 125 on plat of Pineforest Subdivision recorded in the R. M. C. Office for Greenville County in Plat Book QQ, at page 107, and having according to said plat the following metes and bounds, to-wit:
