All that piece, parcel or lot of land, situate in the County of Greenville, State of South Carolina, situate, lying and being on the western side of Brookforest Drive, being known and designated as Lot No. 11 as shown on a plat of section 2 Belle Meade, made by Piedmont Engineering Services, June 1954, and recorded in the R. M. C. Office for Greenville, County in Plat Book EE at Pages 116 and 117, and having according to said Plat, the following metes and bounds to-wit:

Beginning at an iron pin on the western side of Brookforest Drive, said pin being 70 feet from the southwestern intersect on of Brookforest Drive and Williamsburg Drive, thence S. 36-53 W. 154.5 feet to an iron pin; thence S. 50-40 E. 80.45 feet to an iron pin; thence N. 38-20 E. 160 feet to an iron pin on the western side of Brookforest Drive; thence N. 54-49 W. 85 feet to the point of beginning.
