TO ALL WHOM THESE PRESENTS MAY CONCERN:

Jesse B. Lofgreen and May D. Lofgreen  
(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Thirty-seven Thousand Two Hundred and no/100-----  
DOLLARS (\$ 37,200.00----- ), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

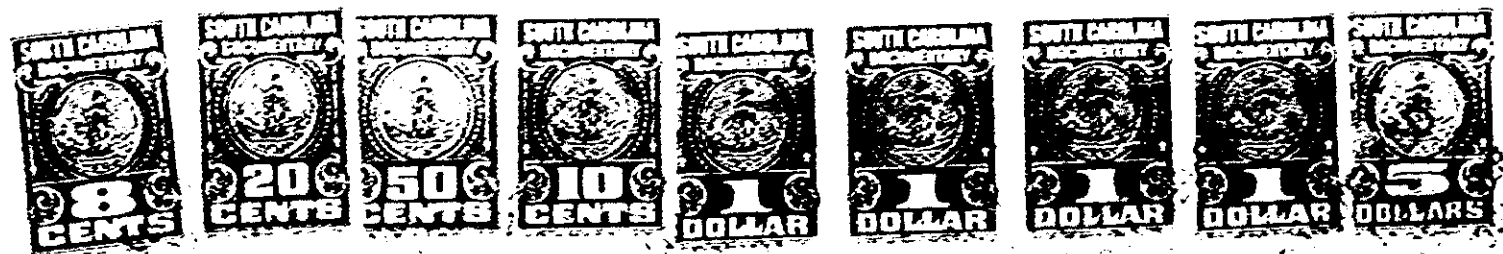
WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable, August 1, 2006

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being

All that certain piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 52 on plat of Haselwood, Section 3, recorded in Plat Book 5D at page 26 and having the following courses and distances:

BEGINNING at an iron pin on Huntscroft Lane at the joint corner of Lots 52 and 53 and running thence with the joint line of said lots, N. 30-50 E. 155 feet to an iron pin at the joint corner of Lots 51, 52, 53, and 54; thence along the joint line of Lots 51 and 52, S. 72-18 E. 271.8 feet to an iron pin on Mellyn Street; thence with said Street, S. 11-45 W. 121.2 feet to an iron pin in the curve; thence with curve of Mellyn Street and Huntscroft Lane, S. 45-50 W. 40.4 feet to an iron pin on Huntscroft Lane; thence with said Lane, the following courses and distances: N. 89-04 W. 66.1 feet to an iron pin, N. 78-10 W. 65 feet to an iron pin, N. 65-30 W. 65 feet to an iron pin, and N. 59-10 W. 111.7 feet to the point of beginning.
