C. Highway 415 and Belvue Road and being shown and designated as the major portion of an unrumbered lot on plat of Property of Ollie B. Barrett recorded in the R. M. C. Office for Greenville County in Plat Book FF, page 485 and having according to said plat the following metes and bounds, to wit:

Beginning at an iron pin on the southwestern side of S. C. Highway No. 415 at the corner of Lot 1 and running thence along S. C. Highway No. 415 S. 54-15 E. 145 feet, more or less, to a point near the corner of the intersection of S. C.
