NOW, KNOW ALL MEN, that Mortgagor (all, if more than one), to secure payment of a Promissory Note of even date from Mortgagor to the above named Mortgagee in the above Total of Payments and all future and other obligations of Mortgagor to Mortgagee, the Maximum Outstanding at any given time not to exceed said amount stated above, hereby grants, bargains, sells, and releases to Mortgagee, its successors and assigns, the following described real estate together with all present and future improvements thereon situated in South Carolina, County of Greenville

ALL that certain piece, parcel or lot of land in Greenville County, State of South Carolina, being shown as Lot #6 on Plat entitled "Property of Joe H. & Mamie S. Black" prepared by C. O. Riddle dated February 1, 1962 and resurveyed March 4, 1971 and having according to said plat the Following metes and bounds, to wit:

Beginning at an iron pin on the Northeasterly side of a road at the joint said corner of Lots 5 and 6 and running thence along the Northeasterly side of said road N. 68-26 W. 125 feet more or less to an iron pin; thence N. 36-00 E. 378 feet to an iron pin in line of Garrison; thence, with said Garrison line S. 54-00 E. 110 feet to an iron pin at the corner of Lot 1 and 6; thence, with the line of Lots 1 and 5 S. 36-00 W. 413 feet to the beginning corner.
