ALL that piece, parcel or lot of land, with all buildings and improvements thereon, situate, lying and being on the southern side of Devenger Road, In Greenville County, South Carolina, being shown as tract containing 1.16 acres on a plat entitled PROPERTY OF PATTERSON-TAYLOR BUILDERS, INC., made by C. O. Riddle, Surveyor, dated April 7, 1976, recorded in the RMC Office for Greenville County, S. C., in Plat Book 58 page 18 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin located on the southern side of Devenger Road, said iron pin being located 470 feet in an easterly direction from the intersection of Devenger Road and Boiling Springs Road, and running thence with the southern side of Devenger Road, N. 73-48 E., 80 feet to an iron pin; thence continuing with Devenger Road, N. 68-56 E., 80 feet to an iron pin; thence S. 20-14 E., 305 feet to an iron pin; thence S. 56-51 W., 35 feet to an iron pin; thence N. 78-17 W., 214.76 feet to an iron pin; thence N. 5-21 W., 204.2 feet to an iron pin, the point of beginning.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all liens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagee forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

(1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or credits that may be made hereafter to the Mortgagor by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.
