RESOLUTION
(Authorizing Bonded Indebtedness)

BE IT RESOLVED THAT SPRINGFIELD BAPTIST CHURCH GREENVILLE
Issuer City
SOUTH CAROLINA (hereinafter referred to as the Issuer) issue and sell its Special Revenue Bonds of
State
serial maturity in the total aggregate amount of \$ 105,000.00 bearing interest at the rate of 8 & 8 1/2
percent per annum compounded semi-annually for the purpose of financing the purchase
Payable or Compounded
of furnishings and final construction costs of the new building
and that a portion of the revenue of the Issuer be appropriated and irrevocably assigned and pledged to pay
the principal and all interest as the same shall come due, which sums shall not exceed the following:

- \$ 737.00 per month for 1 year, then
- \$ 845.00 per month for 1 year, then
- \$ 953.00 per month for 1 year, then
- \$1,083.00 per month for 1 year, then
- \$1,196.00 per month for 10 years

That the BOARD OF TRUSTEES of the Issuer be empowered and instructed to select and
Board - Elders - Trustees - Deacons - Steering Committee
approve, (in consultation with Security Church Finance, Inc.) the Paying Agent Bank, the necessary amount
of proceeds to be escrowed, the dates of the campaign, the date the bonds shall begin earning interest, the a-
mount and type of bond to be placed upon the Treasurer, and to enter into an agreement with Security Church
Finance, Inc. for the preparation of this bond issue, including the type of program and fee.

That all of the necessary instruments and documents pertaining to this bond issue including, but not limited
to:

- The agreement with Security Church Finance, Inc.
- The Resolution describing the terms and conditions of the issue
- The bonds

shall be on forms furnished or approved by Security Church Finance, Inc. and approved and completed by an
attorney-at-law retained by the Issuer and shall be signed for and on behalf of the Issuer by the following de-
signed individuals or their successors in office.
