PARTIAL RELEASE OF LIEN
(Bank Loan No. 43-3-1935501-1/2

KNOW ALL MEN BY THESE PRESENTS, that for and in consideration of the sum of one dollar and other considerations, receipt whereof is hereby acknowledged, The Federal Land Bank of Columbia, the owner and holder of the security instrument hereinafter referred to and of the note(s) thereby secured does, subject to the conditions hereinafter stated, hereby release from the lien of that certain security instrument from Malcolm M. Manning-

to The Federal Land Bank of Columbia, dated the 29th day of March, 1973, and recorded in the public records of Greenville County, State of South Carolina in Mortgage Book 1271, at page 117, the following described property, to-wit:

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, Cleveland Township, containing 6.63 acres, more or less, as shown on a plat of survey entitled "Plat for Norman Radler", surveyed by Webb Surveying & Mapping Co., dated February, 1976, and bounded on the North by property now or formerly of Manning; on the East by property now or formerly of Angeletti; on the South by property now or formerly of Fox; and on the West by a creek.

ALL that certain piece, parcel or lot of land situate, lying and being in the County of Greenville, State of South Carolina, Cleveland Township, containing 10.4 acres, more or less, as shown on a plat entitled "Plat for Gerald D. Fox", surveyed by Webb Surveying & Mapping Co., dated February, 1976, and bounded on the North by lands now or formerly of Radler and Angeletti; on the East by lands now or formerly of Manning; on the South and Southwest by lands now or formerly of Thompson; and on the West by a creek.

PROVIDED, HOWEVER, that the security of The Federal Land Bank of Columbia as described in the aforesaid security instrument shall, in all respects, except as to the premises hereinbefore described, be preserved and protected and that the lien of said security instrument, except as hereby released and discharged, shall remain in full force and effect and the terms, conditions and covenants thereof and of the note(s) thereby secured, shall remain unchanged.
