TO ALL WHOM THESE PRESENTS MAY CONCERN: Gordon E. Mann

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto Julius T. Brown and Rosa Alma Owens Brown

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty-four Thousand and

No/100 ----- DOLLARS (\$ 24,000.00 ),

with interest thereon from date at the rate of eight per centum per annum, said principal and interest to be repaid: payable \$229.36 per month including principal and interest computed at the rate of 8 per cent per annum, the first payment being due June 5, 1976, and a like payment being due on the fifth day of each month thereafter for a total of fifteen years.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

All those lots of land situate on the northerly side of Monaview Circle in the County of Greenville, State of South Carolina, being shown as Lot 4 and Lot 5 on a plat of the property of W. N. Leslie, Inc., dated October 10, 1966, prepared by Carolina Engineering and Surveying Company, recorded in Plat Book NNN at Page 69 in the RMC Office for Greenville County and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northerly side of Monaview Circle at the joint front corner of Lot 3 and Lot 4 and running thence with Lot 3 N. 32-01 E. 110.5 feet to an iron pin at the joint rear corner of Lot 3 and Lot 4; thence S. 51-33 E. 30.6 feet to an iron pin; thence S. 62-35 E. 100.6 feet to an iron pin; thence S. 27-25 W. 110 feet to an iron pin on the northerly side of Monaview Circle; thence with said Circle N. 62-35 W. 112.05 feet to an iron pin; thence still with said Circle N. 51-33 W. 28.1 feet to the point of beginning.

This is the same property conveyed to the mortgagor by deed of the mortgagee to be recorded herewith.
