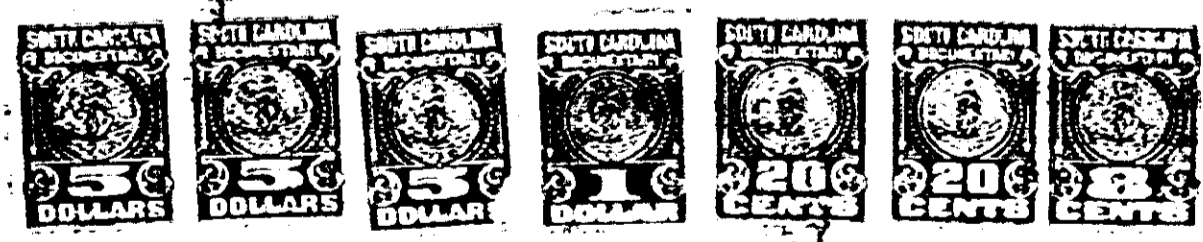
WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable,

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 20 on plat of Hazelwood, Section 2, recorded in Plat Book 5D at page 25, and having the following courses and distances:

BEGINNING at an iron pin on Mellwood Drive, joint front corner of Lots 20 and 21 and running thence with joint line of said lots, S. 18-55 W. 301.9 feet to an iron pin, joint rear corner of said lots; thence along the rear line of Lot 20, S. 69-09 E. 45 feet to an iron pin; thence S. 53-48 E. 45 feet to an iron pin, joint rear corner of Lots 19 and 20; thence with joint line of said lots, N. 40-37 E. 279 feet to an iron pin on Mellwood Drive; thence with said Drive, N. 50-58 W. 110.1 feet and N. 58-25 W. 90 feet to the point of beginning.
