WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

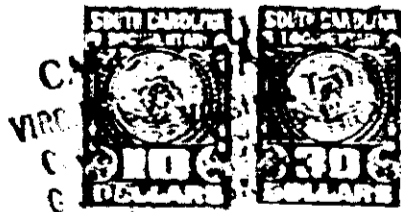

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville, being shown as Lot 16, 17 and a portion of Lots 18 and 19, Block B, on plat of Cagle Park and described collectively as follows:

BEGINNING at an iron pin on the North side of Crescent Avenue at the joint front corner of Lots 15 and 16 and running thence with the line of said lots, N. 0-54 W., 196.8 feet; thence S. 77-44 E., 255 feet; thence S. 0-23 W., 20 feet; thence N. 77-44 W., 91.7 feet; thence S. 0-38 E., 216.7 feet to an iron pin on Crescent Avenue; thence with Crescent Avenue, N. 62-52 W., 73.3 feet; N. 63-55 W., 34.7 feet and N. 67-40 W., 68 feet to the point of beginning.
