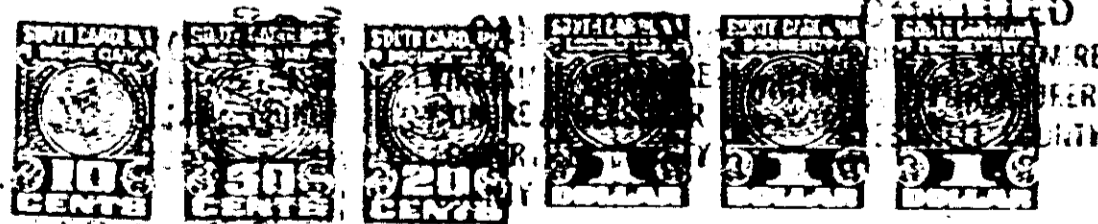
WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable.

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, containing 2.94 acres, more or less, as shown on plat of property of Roy J. & Edith B. Lee recorded in plat book "SS" page 161, and having the following metes and bounds, to-wit:

Beginning at a point in the center of Mountain Creek Church Road at the corner of Babb and running thence with the center of the road S 67 E 101.3 feet to an iron pin; thence with the center of the road S 76-10 E 85.4 feet to an iron pin; thence N 29-50 E 250 feet to an iron pin; thence N 36 E 455 feet to an iron pin in Mountain Creek; thence along the creek as the line, the traverse of which is N 8-44 W 127.4 feet; N 53-17 W 67 feet; thence S 35-36 W 835.4 feet to the point of beginning, and being the same conveyed to us in deed book 625, page 431.
