INSTRUCTIONS

The Mortgapor must subscribe his name to the foregoing mortgape in the space provided therefor, in the presence of two witnesses, who must also subscribe their names in the spaces provided for their signatures. One of said subscribing witnesses, must make and subscribe his name to the affidavit or probate at the foot of the mortgage. The officer before whom said affidavit is made must subscribe the same over his official title and affix his seal thereto.

If the Mortgagor is married, his wife must renounce dower in the manner and form indicated at the end of the mortgage under the heading "Renunciation of Dower." Her name must be inserted in the space provided therefor in the body of the certificate of renunciation, and she must also subscribe her name thereto on the line provided for her signature, using her own given name; for example: Mary Doe, not Mrs. John Doe.
