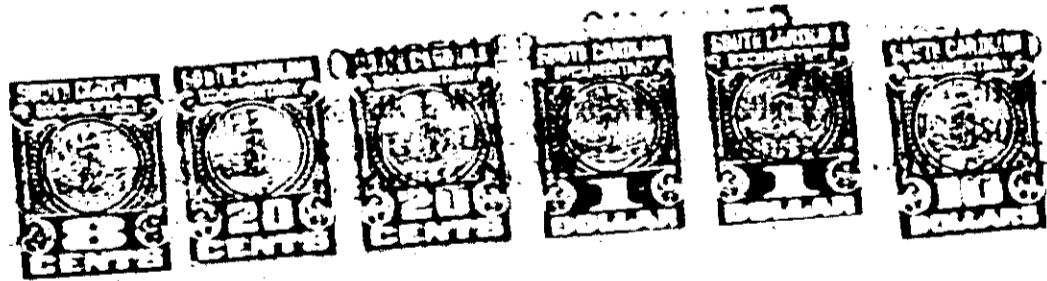

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, and being shown and designated as Lot 48 of Verdin Estates, dated September 21, 1972, prepared by C. O. Riddle recorded in the R. M. C. Office for Greenville County in Plat 4 R at pages 34 and 35, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Baldwin Circle at the joint front corner of Lots 48 and 49; thence, N. 81-05 E., 162 feet to an iron pin; thence, N. 5-32 E., 33 feet to an iron pin; thence, N. 35-08 W., 93 feet to an iron pin; thence, S. 62-50 W., 147.6 feet to an iron pin on the eastern side of Baldwin Circle; thence with Baldwin Circle, S. 17-59 E., 70 feet to an iron pin, the point of beginning.
