That he hereby assigns all the rents, issues, and profits of the mortgaged premises from and after any default hereunder, and should legal proceedings be instituted pursuant to this instrument, then the Mortgager shall have the right to have appointed a receiver of the tents, issues, and profits, who, after deducting all charges and expenses attending such proceedings and the execution of his trust as receiver, shall apply the residue of the tents, issues, and profits toward the payment of the debt secured hereby.

Without affecting the liability of any person (other than any person released parsuant hereto) for payment of any indebtedness secured hereby, and without affecting the priority or extent of the hen hereof upon any property not specifically released pursuant hereto.
