## INSTRUCTIONS

The Mortgapor must subscribe his name to the foregoing mortgage in the space provided therefor, in the presence of two witnesses, who must also subscribe their names in the spaces provided for their signatures. One of said subscribing witnesses, must make and subscribe his name to the affidavit or probate at the foot of the mortgage.
