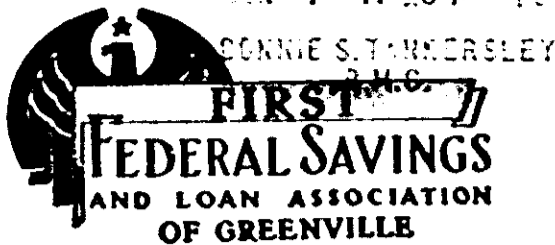

MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

WE, RAJINDER KUMAR AND SHAKTI BALA KUMAR

(hereinafter referred to as Mortgagor) (SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of Twenty Thousand and No/100 ----- 20,000.00 (\$)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, which note does not contain a provision for escalation of interest rate (paragraphs 9 and 10 of this mortgage provides for an escalation of interest rate under certain conditions), said note to be repaid with interest as the rate or rates therein specified in installments of One Hundred Fifty Seven and 35/100 ----- (\$ 157.35) Dollars each on the first day of each month hereafter, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 30 years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall at the option of the holder thereof, become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagee's account for the payment of taxes, insurance premiums, repairs, or for any other purpose.

NOW, KNOW ALL MEN, That the Mortgagee, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagee in hand well and truly paid by the Mortgagor at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, being and lying in the State of South Carolina, County of Greenville, on the eastern side of Seminole Drive, in the Town of Simpsonville, being shown and designated as Lot No. 93 on a plat of WESTWOOD, SECTION II, Sheet No. 1, made by Piedmont Engineers & Architects, dated September 16, 1970, recorded in the R.M.C. Office for Greenville County, South Carolina in Plat Book 4-F at page 44, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Seminole Drive at the joint front corner of Lots Nos. 93 and 94; and running thence with the common line of said lots, N. 44-15 E., 235.0 feet to an iron pin in or near a creek; thence with the creek as the line, the traverse of which is N. 40-27 W., 74.13 feet to an iron pin at the joint rear corner of Lot Nos. 92 and 93; thence with the common line of said lots, S. 45-43 W., 242.0 feet to an iron pin on the eastern side of Seminole Drive; thence with the eastern side of Seminole Drive, S. 45-48 E., 80.0 feet to an iron pin, the point of BEGINNING.

The above described property is the same property conveyed to the mortgagors herein by deed of Helen M. O'Brien dated May 13, 1976, to be recorded herewith, in the R. M. C. Office for Greenville County, South Carolina.
