TO ALL WHOM THESE PRESENTS MAY CONCERN:

Charles H. Myers and Regina D. Myers

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Sixty-four Thousand and no/100----- DOLLARS

(\$ 64,000.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is thirty years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the southwestern corner of the intersection of East Seven Oaks Drive and Chapman Road and being known and designated as lot no. 117-A as shown on plat of Revision of Lots 114, 115, 116 and 117 of Chanticleer, Section II, prepared by Campbell and Clarkson, dated August 21, 1967 and recorded in the R.M.C. Office for Greenville County in Plat Book RRR at Page 141 and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of East Seven Oaks Drive at the joint front corner of lots 115-A and 117-A and running thence along said Drive S. 54-49 E. 92.3 feet to an iron pin; thence continuing with said Drive S. 48-02 E. 82.9 feet to an iron pin; thence with the curve of the intersection of East Seven Oaks Drive and Chapman Road S. 4-45 W. 33.8 feet to an iron pin; thence along the northwestern side of Chapman Road S. 49-0 W. 120.1 feet to an iron pin; thence continuing along said Road S. 51-30 W. 35 feet to an iron pin; thence N. 46-46 W. 154.7 feet to an iron pin; thence N. 35-11 E. 167.5 feet to the point of beginning.
