(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto LAURENS FEDERAL SAVINGS AND LOAN ASSOCIATION, LAURENS, S. C. (hereinafter referred to as Mortgagee), as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference in the sum of

DOLLARS (\$ 50,000.00), with interest thereon from date at the rate provided for in said note, said principal and interest to be repaid as therein stated, except that the final payment of principal and interest shall be due on
June 1, 1986, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the Town of Simpsonville, being located on the Northerly side of College Street, and having the following metes and bounds, to wit:

BEGINNING at a point on the Northerly side of College Street located 206 feet from N. Main Street and running thence N. 25 W. 100 feet to a corner; thence N. 65 E. 75 1/2 feet to a corner; thence S. 25 E., 100 feet to a corner in College Street; thence along College Street S. 65 W. 75 feet to the beginning corner.

ALSO: All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, Town of Simpsonville, being located on the Easterly side of a 25 foot alley running from College Street and having the following metes and bounds, to wit: BEGINNING at an iron pin on the Eastern side of said 25 foot alley and running thence N. 65 E., 100 feet to an iron pin; thence N. 25 W., 92 feet to an iron pin; thence S. 65 W., 100 feet to an iron pin on alley; thence along alley S. 25 E., 92 feet to the beginning corner.

ALSO: All that certain piece, parcel or lot of land in Greenville County, State of South Carolina, Town of Simpsonville, being located on the Northerly side of College Street and having the following metes and bounds, to wit: BEGINNING at an iron pin on the Northerly side of College Street and running thence N. 25 W., 100 feet to a corner; thence N. 65 E., 24 1/2 feet to a corner; thence along property now or formerly of Wood, S. 25 E., 100 feet to a corner on College Street; thence with the Northerly side of College Street S. 65 W., 25 feet to the beginning corner.

This being the same property conveyed to the mortgagor herein by Deed of Geo. W. Webb, dated May 28, 1973, and recorded in Deed Volume 992 at page 31.
