N. 35-18 E. 481.85 feet to an iron pin in the line of property now or formerly of Lowell S. Cross; thence with the line of property now or formerly of Lowell S. Cross the following courses and distances: S. 14-50 E. 130.9 feet to an iron pin; S. 22-41 E. 92.3 feet to an iron pin; S. 38-25 E. 92.3 feet to an iron pin; S. 46-16 E. 25 feet to an iron pin on the northwestern side of Devenger Road; thence along the northwestern side of Devenger Road the following courses and distances: S. 43-44 W. 50 feet to an iron pin; thence S. 35-42 W. 25 feet to an iron pin; thence S. 29-12 W. 50.1 feet to an iron pin; thence S. 21-27 W. 75 feet to an iron pin at the point of beginning.
