Caryl B. Arthur (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Thirty Eight Thousand, Three Hundred and Fifty and No/100---- DOLLARS

(\$ 38,350.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Rosemary Lane, and being shown and designated as Lot No. 2 on plat entitled "Revision of Lots 31, 32, 33, Rosedale", said plat being recorded in the RMC Office for Greenville County in Plat Book WWW, Page 60, and according to said plat, having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Rosemary Lane at the joint front corner of Lots 1 and 2, and running thence with the line of Lot 2, S. 7-41 W. 259.3 feet to an iron pin; thence S. 40-0 E. 74 feet to an iron pin; thence N. 76-15 E. 104 feet to an iron pin; thence N. 84-25 E. 78.4 feet to an iron pin at the rear corner of Lot 3; thence with the line of Lot 3, N. 24-39 E. 317 feet to an iron pin on the southern side of Rosemary Lane; thence with the southern side of Rosemary Lane, S. 84-04 W. 61 feet to the beginning corner.
