To All Whom These Presents May Concern:

We, Charles C. Bradley, Jr. and Sibyl C. Bradley SEND GREETING:

WHEREAS, we the said Charles C. Bradley, Jr. and Sibyl C. Bradley in and by our certain promissory note in writing of even date with these Presents, are well and truly indebted unto the CITIZENS BUILDING AND LOAN ASSOCIATION, Greer, S. C., in the full and just sum of **Fourteen Thousand and No/100** ----- (\$ 14,000.00) Dollars, with interest from the date hereof at the rate of **eight 1/2** per cent (8 1/2 %) per annum, unpaid interest to bear interest at the same rate, to be repaid in installments of **One Hundred thirty seven and 87/100** - ----- (\$ 137.87) Dollars

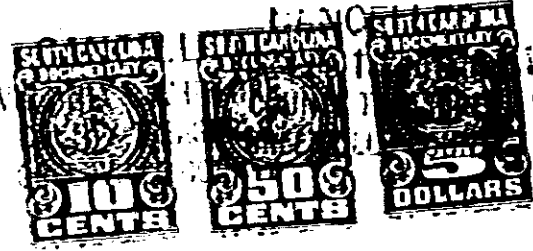
