MORTGAGE OF REAL ESTATE
TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, Irvine Street Realty Corp.

(hereinafter referred to as Mortgagor) is well and truly indebted unto South Carolina National Bank, Greenville, South Carolina,

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Seventy Thousand Three Hundred Twenty-Four and 80/100----- Dollars (\$ 70,324.80) due and payable

as per the terms of said note;

with interest thereon from date at the rate of ten per centum per annum, to be paid: as per the terms of said note.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in a section known as Freetown near the City of Greenville, lying in front of Friendship Baptist Church and containing one acre, more or less, and having the following metes and bounds, to-wit:

BEGINNING on the west side of Church Street at the corner of Goodlett Estate land; thence with Goodlett line N. 84-15 W. 142 feet to a pin; thence N. 13-27 W. 348.9 feet to a pin; thence S. 80-38 E. 139.3 feet to a pin on the west side of Church Street; thence with the west side of Church Street S. 15 E. 342.8 feet to the beginning corner.
