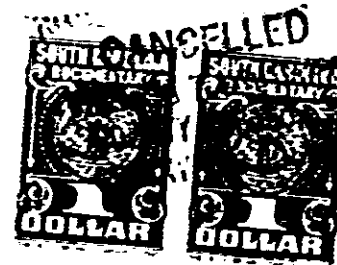
Five Thousand and No/100 ----- DOLLARS (\$5,000.00 )
