JACK F. BILYEU AND GLENNA E. BILYEU (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

\*All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville,

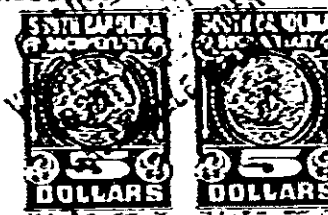

Beginning at an iron pin on the northwestern side of Wolseley Road at the joint front corner of Lots 198 and 199; thence with line of Lot 198, N. 46-30 W. 130 feet to an iron pin; thence N. 43-30 E. 95 feet to an iron pin at joint rear corner of Lot 197; thence with Lot 197, S. 46-30 E. 130 feet to an iron pin on Wolseley Road; thence with said Road, S 43-30 W. 95 feet to the beginning corner.
