-----Dollars (\$ 29,000.00--), with interest from date at the rate of eight & one-half per centum (8.50 %) per annum until paid, said principal and interest being payable at the office of Lincoln Home Mortgage Company

in Atlanta, Georgia, or at such other place as the holder of the note may designate in writing delivered or mailed to the Mortgagor, in monthly installments of Two Hundred Twenty-

Now, KNOW ALL MEN, that Mortgagor, in consideration of the aforesaid debt and for better securing the payment thereof to the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, assigned, and released, and by these presents does grant, bargain, sell, assign, and release unto the Mortgagee, its successors and assigns, the following-described property situated in the county of State of South Carolina;

All that certain piece, parcel or tract of land lying in the State of South Carolina, County of Greenville, Highland Township, fronting on Mt. Lebanon Church Road, containing 11.10 acres according to Plat of Property of Carroll Wayne Stewart and Rhyland D. Stewart, recorded in the RMC Office for Greenville County in Plat Book 57 at page 50 and having such courses and distances as will appear by reference to said plat.
