TO ALL WHOM THESE PRESENTS MAY CONCERN:

W. HAROLD MOORE and FAY (hereinafter referred to as Mortgagor) SEND(S) GREETING:  
G. MOORE

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Six Thousand Five Hundred and no/100-----DOLLARS

(\$6,500.00 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is eight (8) years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the eastern side of Old Grove Road, near the City of Greenville as shown on a plat of property of J. R. Moore, prepared by C. O. Riddle, R.L.S., dated August 20, 1957, revised July 30, 1973 and being described, according to said plat, more particularly, to-wit:

BEGINNING at an iron pin off the eastern side of Old Grove Road and running thence S. 79-10 E. 24.2 feet to an iron pin; thence S. 10-50 W. 156 feet to an iron pin; thence S. 82-56 W. 75.6 feet to an iron pin; thence N. 25-42 E. 185.5 feet to an iron pin, the point of beginning.

Also: ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, at the southeastern corner of the intersection of Old Grove Road and Dixie Circle (sometimes known as County Road), designated as Lot 2 on plat of property of J. R. Moore, prepared by C. O. Riddle, R.L.S., dated August 20, 1957 showing lots 2 and 3 as being surveyed May 20, 1960 and being more particularly described, according to said plat, as follows:

BEGINNING at an iron pin at the joint front corner of Lots 2 and 3 and running thence along the eastern side of Old Grove Road N. 25-42 E. 131.6 feet to an iron pin; thence N. 66-21 E. 30.3 feet to an iron pin on the southern side of Dixie Circle (sometimes called County Road); (OVER)

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
