WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of TWENTY-ONE THOUSAND SIX HUNDRED AND NO/100-----DOLLARS

(\$ 21,600.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 30 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Chick Springs Township, being shown and designated as Lot 21 on plat of Rosedale, recorded in Plat Book YY, at Page 35, in the R.M.C. Office for Greenville County, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Western side of Ivanhoe Circle at the corner of Lot No. 20; thence with line of said lot, N. 73-52 W. 130-feet to an iron pin on line of Lot No. 19; thence with line of said lot, S. 16-08 W. 50-feet to a stake; thence N. 73-52 W. 110-feet to an iron pin; thence S. 15-43 E. 191.3-feet to an iron pin; thence N. 72-40 E. 200-feet to an iron pin on said Circle; thence with said Circle, N. 6-24 W. 56.5-feet to a stake; thence with said Circle, N. 8-58 E. 49.9-feet to beginning corner. This is the same property conveyed by G. L. Greer in Deed Book 1016 Page 569.
