MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, We, Robert L. Goodlett and Elizabeth R. Goodlett

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 6 on Courtney Circle according to survey made by T. H. Walker, Jr., Reg. L. S. 3182 dated February 16, 1976, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwesterly side of Courtney Circle, joint front corner of Lot No. 5 and 6, and running thence S. 67-05 E. 80 feet to an iron pin; thence turning and running along the common line of Lot No. 6 and 7 S. 22-55 W. 180 feet to an iron pin; thence turning and running N. 67-05 W. 80 feet to an iron pin; thence turning and running along common line of Lot No. 6 and 5 N. 22-55 E. 180 feet to an iron pin, the point of beginning.

This being the same property conveyed unto the Mortgagors herein by deed from Audrey S. Goldsmith, as Executrix under the Estate of Sloan E. Goldsmith recorded August 26, 1976.
