THIS MORTGAGE is made this 31st day of August 1976, between the Mortgagor, Samuel L. Finklea, III and Deidra R. Finklea (herein "Borrower"), and the Mortgagee, South Carolina Federal Savings & Loan Association a corporation organized and existing under the laws of United States of America whose address is 1500 Hampton Street Columbia, South Carolina (herein "Lender").

WHEREAS, Borrower is indebted to Lender in the principal sum of Twenty-eight Thousand Four Hundred Fifty and no/100 Dollars, which indebtedness is evidenced by Borrower's note dated August 31, 1976 (herein "Note"), providing for monthly installments of principal and interest, with the balance of the indebtedness, if not sooner paid, due and payable on September 1, 2001

To SECURE to Lender (a) the repayment of the indebtedness evidenced by the Note, with interest thereon, the payment of all other sums, with interest thereon, advanced in accordance herewith to protect the security of this Mortgage, and the performance of the covenants and agreements of Borrower herein contained, and (b) the repayment of any future advances, with interest thereon, made to Borrower by Lender pursuant to paragraph 21 hereof (herein "Future Advances"), Borrower does hereby mortgage, grant and convey to Lender and Lender's successors and assigns the following described property located in the County of _____ State of South Carolina:

All that piece, parcel or lot of land lying in the State of South Carolina, County of Greenville, shown as Lot 149 on plat of Glendale, recorded in Plat Book QQ at pages 76 and 77 and having the following courses and distances:

Beginning at a point on the northwestern side of Fairfield Drive at the joint front corner of Lots 148 and 149 and running thence N. 40-14 W. 175 feet to a point at the joint rear corner of Lots 148 and 149; thence S. 49-46 W. 100 feet to a point at the joint rear corner of Lots 149 and 150; thence S. 40-14 E. 175 feet to an iron pin on the northwestern side of Fairfield Drive; thence with the northwestern side of Fairfield Drive, N. 49-46 E. 100 feet to the point of beginning.

Borrower covenants that Borrower is lawfully seised of the estate hereby conveyed and has the right to mortgage, grant and convey the Property, that the Property is unencumbered, and that Borrower will warrant and defend generally the title to the Property against all claims and demands, subject to any declarations, easements or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring Lender's interest in the Property.
