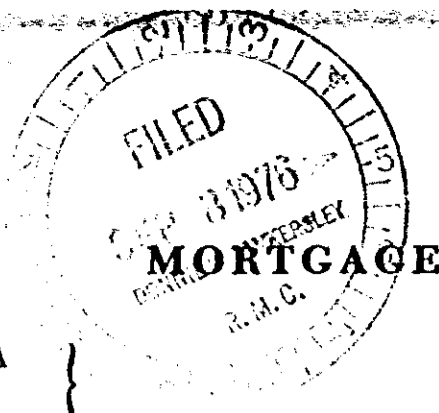

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Four thousand seventeen dollars and 60/100

DOLLARS

(\$ 4,017.60 ), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is three years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, situate on the southwestern corner of the intersection of Maudie Street and Old Augusta Road being shown on a plat of the property of James E. and Margiree Harrison made by J. C. Hill, dated July 11, 1963, and recirded in the RMC Office for Greenville County in Plat Book DDD at Page 133 and having, according to said plat, the following metes and bounds, to-wit:

Beginning at an iron pin at the Southwestern corner of the intersection of Maudie Street and Old Augusta Road and running thence with the Southern side of Maudie Street, S 55 W 125 feet to a pin; thence S. 2-25 E 205 feet to an iron pin; thence N 61-55 E 125 feet to a pin in the center of Old Augusta Road; thence with the center of Old Augusta Road N. 2-25 W. 215 feet to the point of beginning.

This is the same property conveyed to the Mortgagors by deeds recorded in Deed Book 412 at Page 459 and by deed recorded in Deed Book 728 at Page 5 in the RMC Office for Greenville County.
