TO ALL WHOM THESE PRESENTS MAY CONCERN: we, Richard E. Arnold and Marie M.

Arnold (hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of Twenty-Eight Thousand, Five Hundred and No/100----- DOLLARS

(\$ 28,500.00), as evidenced by the Mortgagor's note of even date, bearing interest as stated in said note, and payable as therein stated or as modified by mutual agreement, in writing, the final maturity of which is 25 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Butler Township, near and East of the City of Greenville, and being known and designated as Lot Number 35 of a subdivision known as Terra Pines Estates Section 4, a plat of which is of record in the R. M. C. Office for Greenville County in Plat Book 000 at Page 85, and having the following metes and bounds, to-wit:

"BEGINNING at a point on the Northwestern side of Compton Drive at the joint front corner of Lots 34 and 35 and running thence with the Northwestern side of Compton Drive, N. 19-30 E. 193.6 feet to a point; thence continuing with the Northwestern side of Compton Drive, N. 21-30 E. 70 feet to a point at the joint front corner of Lots 35 and 36; thence N. 66-30 W. 160 feet to a point at the joint rear corner of Lots 35 and 36; thence S. 22-10 W. 274.9 feet to a point at the joint rear corner of Lots 34 and 35; thence S. 70-30 E. 170 feet to a point on the Northwestern side of Compton Drive at the point of beginning; being the same conveyed to the mortgagors by Central Realty Corporation by deed dated September 17, 1968 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 856, at Page 213."
