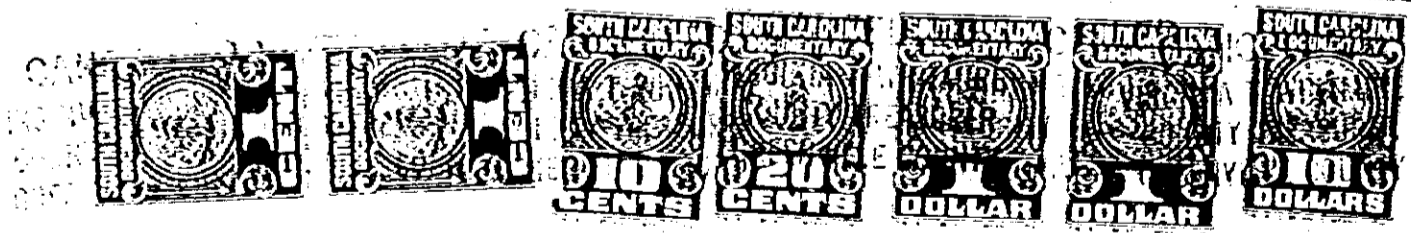
NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot 37, Mountainbrooke Subdivision, Plat of which is recorded in the RMC Office for Greenville County in Plat Book 4-F, at Page 47, and having, according to said plat, the following metes and bounds:

Beginning at an iron pin on the southeastern side of Crosscreek Lane at the joint front corner of Lots 36 and 37, and running thence along the common line of said Lots, S 48-00-50 E, 165 feet to an iron pin; thence N 43-18-00 E, 164.61 feet to an iron pin; thence N 74-37-40 W, 188.7 feet to an iron pin on Crosscreek Lane; thence S 41-59-10 W, 80 feet to the point of beginning.
