(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, in the sum of:

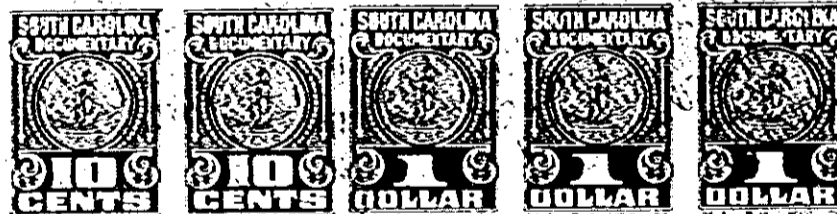
-----EIGHT THOUSAND & NO/100----- Dollars

ALL that certain piece, parcel or lot of land in the State of South Carolina, County of Greenville, lying and being on the southern side of Circle Road, being shown as 5.46 acres on plat of Property of Venture Associates, Ltd., made by C.
