All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 98, Charter Oak Drive, Peppertree Subdivision, Section No. 2 as shown on a plat recorded in the Office of the R.M.C. for Greenville County in Plat Book 4R at Page 19, revised in Plat Book 4X at Page 3, and having, according to said plat, the following metes and bounds to-wit:
