And it is further agreed, in the event of other insurance and contribution between the insurers, that the said mortgagee

their heirs, executors, AND IT IS AGREED, by and between the said parties, that if the said mortgagor, administrators or assigns, shall fail to pay all taxes and assessments upon the said premises when the same shall first become payable. Domestic Loans of Greenville, Inc. their successors then the said mortgagee, or assigns, may cause the same to be paid, together with all penalties and costs incurred thereon, and reimburse themselves under this mortgage for the sums so paid, with interest thereon, from the dates of such payments.

AND IT IS AGREED, by and between the said parties, that upon any default being made in the payment of the interest on the aid Note, or of the insurance premiums, or of the taxes, or of the assessments hereinabove mentioned, when the same shall severally first become payable, or in any other of the provisions of this mortgage, that then the entire amount of the debt secured, or

mixinded to be secured hereby, shall forthwith become due, at the option of the said mortgagee, as aforesaid or assigns, although the period for the payment of the said debt may not then have expired.

AND IT IS AGREED, That if the holder of the Note secured hereby is compelled to pay any taxes upon the debt represented by said note, or by this mortgage, then, and in that event, unless the said taxes are paid by some party other than the said holder, that then the entire amount of the debt secured, or intended to be secured, shall forthwith become due at the option of the said mortgagee, or assigns, although the period for its payment may not then have expired as aforesaid

AND IT IS AGREED, by and between the said parties, that, should legal proceedings be instituted for the collection of the debt as aforesaid secured hereby, then and in that event, the said mortgagee, shall have the right to have a Receiver appointed of the rents and profits of the above-described premises, with power to forthwith lease out the said premises anew if he should so elect, who, after deducting all charges and expenses attending such proceedings, and the execution of the said trust as Receiver, shall apply the residue of the said rents and profits towards the payment of the debts secured

hereby.
