This mortgage, made this the 23 day of SEPTEMBER, 19 76,

hereinafter called the Mortgagor (whether one or more persons), in the State aforesaid, Witnesseth:

WHEREAS, the said Mortgagor is truly indebted unto AMERICAN CREDIT COMPANY OF
SOUTH CAROLINA, INC., a corporation, organized
and existing under the Laws of the State of South Carolina, hereinafter called the Mortgagee, in the sum of
Four Thousand Two Hundred Twenty-Four and No/100ths (\$ 4,224.00) Dollars,
as evidenced by promissory note of even date herewith, payable to the order of Mortgagee in 48 consecutive
monthly installments of \$ 88.00 each; the first installment being due November 2,
19 76, and the remaining installments are due on the same day of each month thereafter.

NOW, KNOW ALL MEN BY THESE PRESENTS, That the said Mortgagor in consideration of the said debts
and sums of money aforesaid and for the better securing the payment thereof and also to secure the payment of any
other sums advanced to said Mortgagor under the terms and provisions of this Mortgage as hereinafter set forth,
to the said Mortgagee according to the condition of said note, and also in consideration of the further sum of Three
Dollars to the said Mortgagor in hand well and truly paid by the said Mortgagee, at and before the sealing and
delivery of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released and
by these Presents do grant, bargain, sell and release unto the said Mortgagee, its successors or assigns, the following
described property situated in the County of Greenville, State of South Carolina:

ALL that piece, parcel or lot of land on the south side of Pine Creek Drive near the
City of Greenville, Greenville County, South Carolina, designated as Lot 56 on plat of
Belle Meade prepared by Piedmont Engineering Service in June 1954, being recorded in the
RMC Office for Greenville County in Plat Book EE at Page 116, and having, according to
said plat, the following metes and bounds:

BEGINNING at a point on the south side of Pine Creek Drive at the joint front corner of
Lots 55 and 56, running thence with Pine Creek Drive S. 61-42 W. 75 feet to a point,
thence S. 28-18 E. 159 feet to a point at the joint rear corner of Lots 56 and 57,
running thence N. 61-42 E. 75 feet to the joint rear corner of Lot 55, thence with the
line of Lot 55 N. 28-18 W. 159 feet to the point of beginning.
