TO ALL WHOM THESE PRESENTS MAY CONCERN: SYBLE I. KING

(hereinafter referred to as Mortgagor) SEND(S) GREETING:

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the County of Greenville, State of South Carolina, and being known and designated as Lot No. 4, Block C, according to a plat entitled "Melrose Land Company", said plat being recorded in the R.M.C. Office for Greenville County in Plat Book A at Page 157, and being 50 feet wide and having a depth of 140 feet.
