All that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, about two and one-half miles from Greenville County Court House, on the Northeast side of Hilltop Avenue, near the Franklin Road, and being known as Lot No. 45 on plat of the property of Colonia Company, made by Dalton and Neves, Engrs., September, 1925, recorded in Plat Book "G" at page 112, and having, according to said plat, the following metes and bounds, to-wit:
